CURRENT CATALOG DESCRIPTION:

A study of a major movement, theme, or figure in the development of European philosophy since Kant. Possible topics include: Kant and Neo-Kantianism, the development of post-Kantian Idealism, Hegel, Phenomenology, Marx and Marxism, Continental Aesthetics, Existentialism, the Frankfurt School, French post-structuralism. This course is repeatable up to 6 credits or 2 attempts.

A study of a major movement, theme, or figure in the development of European philosophy since Kant. This course is repeatable up to 6 credits with different topics.

RATIONALE FOR CHANGE:

1. The proposed description differs only in clarifying that the course is repeatable only with different topics. Also, possible topics needn't be included in course description since they are included elsewhere in the catalog description.
2. Change in Prerequisites: we are altering the prerequisites for all of our 400 level courses in this way in order to encourage enrollment but still require some philosophy background.
3. Change in Recommended preparations: The proposed change would capture the key point that PHIL 420 is at a higher level than 300 level courses, and so we are recommending that students have taken at least one 300 level course before taking PHIL 420. And PHIL 322 is an especially useful preparation for PHIL 420.

We do want two distinct recommendations for all of our 400 level courses: that the student have taken SOME 300 level philosophy, and that the noted ones are especially helpful because of their particular content. If we are forced to choose between these distinct recommendations (which we think is really a mistake), then we will choose “one philosophy course at the 300 level” rather than recommendations of particular courses. But we think that students should be aware of both facts — that the course is conducted at a higher level than 300 level courses, and that the content of particular courses at the 300 level is supportive of the content in this particular 400 level course.
