### Specifics (see instructions):

The Writing Board recommends that a change in pre-requisites be implemented for all current and future courses approved as meeting the writing intensive requirement (WI). The Board recommends that prior to taking a writing intensive course students must have completed ENGL 100 or its equivalent. To date, departments have not been required to list English composition as a pre-requisite, but the Board feels strongly that this should be an expectation.

## Rationale (see instructions):

The Writing Board is making this request at this time because we feel it is something that should have been a consideration when the writing intensive requirement was developed. This need is now more evident since the campus has moved forward with requiring students to complete ENGL 100 in their first 30 credits and also with the expectations in Senate Bill 740, which has asked for the completion of English Composition to occur at an even earlier point in the first year. When the Writing Board first proposed this requirement, the hope was that WI courses would be limited to 300- and 400-level classes, which normally would mean that students would have completed English Composition. Since what was finally approved did not specify that WI courses had to be upper-level, we do have a few classes that students could very likely take as WI before completing ENGL 100. Additionally, there is nothing to stop a department from requesting a WI designation for a lower level class; although such an occurrence is not likely. We feel that it is important to close this very important loop-hole, so we can ensure that students are taking their WI course having utilized our curriculum to give them the best possible opportunity to complete the WI course at a high level.

Dear Department Chairs and Program Directors,

I am writing on behalf of the members of the Writing Board (WB) to request your support for a change related to the Writing Intensive Program. I apologize for the length of this e-mail, but many of you probably do not know the history of the Writing Board.

WB members are hoping to move forward with a request to the Undergraduate Council (UGC) that all Writing Intensive (WI) courses have ENGL 100, or its equivalent, formally listed in the catalog and schedule of classes as a pre-requisite. Many of your WI courses are upper-level and this change will have no impact on the students in your classes, but we know there is some potential for impact on those courses that are currently WI that are 100- and 200-level courses.

When the Writing Board first developed the WI proposal, at the request of the General Education Committee, the hope was that WI courses would be limited to 300- and 400-level classes, which normally would mean that students would have completed English Composition. Since what was finally approved did not specify that WI courses had to be upper-level, we do have a few classes that students could very likely take as WI before completing ENGL 100, although Senate Bill 740 minimizes the likelihood of this happening. Additionally, in what was approved, there is nothing to stop a department from requesting a WI designation for a lower level class. Although such an occurrence is not likely, we feel that it is important to close this very important loop-hole. By doing so, we can ensure that students are taking their Writing Intensive course having utilized our curriculum to give them the best possible opportunity to complete the WI course at a high level.

As we move this change forward, it is important for us to have the support of departments offering WI courses. This change will mean that ENGL 100 will have to be listed as a pre-requisite on your current and future WI listings. After talking with the chair of the UGC, it was agreed that this change could be facilitated through the WB's request as long as we have e-mail confirmation of each department's approval. This would mean that each of you would not have to submit your own program change to the UGC. It is our hope that this will make the approval process easier for everyone involved. Once approved, we will also make this change known to the Registrar's Office and facilitate the necessary changes in the catalog and schedule of classes.

If you are comfortable with us moving this request through the UGC, you need only indicate that in an e-mail response to me. If you have questions regarding this, we certainly want to have an opportunity to address those concerns. Simply share those questions with me, and I will make sure the Board members review your questions.

Response Request: It is my hope that I could have responses from all departments no later than November 4, 2015 for review by the UGC at their December 3rd meeting.

Thank you so much for the work you and your department have already done in support of the WI program. It is our hope that this change will serve to improve the student outcomes in your departmental WI offerings.

I have copied Zoe, our undergrad program director, on this reply in case she has any additional suggestions or comments. All of the approved WI courses in Psyc are 400-level, and we do not have any plan to change that (except perhaps to add some additional courses to our list of 400-level WI options). I see no problem with including ENGL 100 as an explicit pre-req for our WI courses, but would also like to point out that I believe this is not necessary. In our new major requirements, ENGL 100 is a pre-req for PSYC 211, which is a required course for the major. PSYC 211 is a prereq for PSYC 311, which is a prereq for all 400-level PSYC courses. Therefore, ENGL 100 is, in effect, required before anyone can take a PSYC WI course.


