PROPOSED CATALOG DESCRIPTION (no longer than 75 words):

This course provides the opportunity for IS majors, particularly those enrolled in the Health IT certificate program, to earn academic credit while employed in a professional internship position that is related to Health IT. The course is repeatable to a maximum of six credits. Pass/fail grading only. Requires a GPA of 2.5 or better, at least 30 credits completed towards graduation, and co- enrollment in the Career Center's PRAC. Department permission required.

RATIONALE FOR NEW COURSE:

- a) Why is there a need for this course at this time? The IS department already has a similar internship course, IS 399, and an internship course specific to cybersecurity, IS 478. The rationale for a third one for Health IT is to simplify administration of the proposed Health IT certificate, for which a Health IT-related internship fulfills one of the requirements. The new course, IS 397, will be similar in structure to our current internship course (a weekly journal, plus a paper at the end of the semester) and will be overseen by the department's UPD or Associate UPD, who will also determine when an internship is Health IT-related, and who will grant permissions for the course.
- b) How often is the course likely to be taught? Every semester
- c) How does this course fit into your department's curriculum?

 This course is one of two that fulfills the Health IT "experience" requirement.
- d) What primary student population will the course serve?
 Undergraduate IS majors who have declared the Health IT certificate.
- e) Why is the course offered at the level (ie. 100, 200, 300, or 400 level) chosen? It is upper-level, as is our current internship course.

- f) Explain the appropriateness of the recommended course preparation(s) and prerequisite(s). The GPA and credits completed prerequisites are intended to discourage low-performing and very new students from pursuing internships. The PRAC prerequisite is required so that the internship can be tracked and overseen by the Career Center.
- g) Explain the reasoning behind the P/F or regular grading method. This course is pass/fail, as is typical of internship courses.
- h) Provide a justification for the repeatability of the course.

 This course is repeatable to allow for up to two semesters of internship experience.
