CURRENT CATALOG DESCRIPTION:

An exploration of media theory and film/video criticism. An investigation of the central issues of the cinematic experience through the ways theorists have explained cinema, television, video and their expanded forms from inception to the present. Through reading how authors have framed media and their makers, students will consider how to create meaning with time-based media

RATIONALE FOR CHANGE:

The change to the prerequisite will enable students pursuing a Visual Arts Minor, which does not require a portfolio review, to enroll in this course. Additionally we have removed ART 324 and ART 325 in order to allow students from other disciplines to be able to enroll in the class with greater ease. This latter change does not reflect a shift in the curriculum, but rather more accurately reflects the current curriculum, which does not rely on previous knowledge of film/video history.
