

UMBC UGC Instructions for Change in Existing Course Form (Revised 10/2020)

Date submitted: The date that the form will be submitted to the UGC.

Course number & title: Enter the current course number and title of the course at the top of the page.

Cross-listed courses: All cross-listed course numbers must be listed in the course number box. Requests to change cross-listed courses must be accompanied by letters of support via email from all involved Department chairs. Proposals for the addition of a cross-listing to an existing course must include as a part of the rationale the specific reason why cross-listing is appropriate. Email from all involved department chairs is also required when cross-listing is removed and when a cross-listed course is discontinued. Please note that Special Topics cannot be cross-listed.

Contact information: Provide the contact information of the Chair or UPD of the department housing the course. If the course is not housed in a department or program, then provide the same information for the head of the appropriate academic unit. (See UGC Procedures.) If another faculty member should also be contacted for questions about the request and be notified about UGC actions on the request, include that person's contact information on the second line.

Course information: Provide all of the current information for this course. Check the "change" column for aspects of the course that will be changed by this proposal and provide the specific changes. Unchanged fields may be left blank under the "proposed" column. *Note: all 300- and 400-level courses must have prerequisites or recommended preparation.*

Course number: For cross-listed courses, provide all the numbers for the course.

Transcript title: Limited to 30 characters, including spaces. Leave the current transcript title blank if this is not known.

Recommended Course Preparation: *Please note that all 300 and 400 level courses should have either recommended course preparation(s) or prerequisite(s) and that 100 or 200 level courses may have them.*

Here fill in what previous course(s) a student should have taken to succeed in the course. These recommendations will NOT be enforced by the registration system. Please explain your choices in the "rationale" (discussed below).

Prerequisite: *Please note that all 300 and 400 level courses should have either recommended course preparation(s) or prerequisite(s)* Here fill in course(s) students need to have taken before they enroll in this course. CURRENT CATALOG DESCRIPTION (required):

Through a group-centered structure students will explore, present, debate and write about human-derived systems and their relationship to urban communities. Projects will result in an understanding of system overlap through graphic explorations, sketching, mapping, and model building. Students will gain an understanding of how designers operate within and alongside systems as modern thinkers and organizers of information, people, and political media. A deeper understanding of the crossover of professional disciplines will be reached.

Students will explore, present, debate, and write about human-derived systems and their relationship to urban communities through group-centered projects that involve sketching, mapping, and model building. Students will understand how Design professionals operate within and alongside systems as entrepreneurial thinkers and organizers of information, people, the built environment, and other human-made systems. A deeper understanding of the crossover of professional disciplines will be reached.

RATIONALE FOR CHANGE:

ART 339 is being added as a requirement to the BFA in Design as part of the NASAD accreditation process. The prerequisite change is necessary to manage enrollment numbers and ensure that BFA in Design majors are able to enroll in the course. The course description was revised to provide more clarity of the course content to the students. The course name change was done in consultation with Gib Mason to reduce student confusion between ART 339 and ENTR 350 “Design Thinking”. Per discussion with Gib Mason, ENTR 350 will be renamed to “Design Thinking for the Entrepreneur”. The key differences are ART 339 learns about Design Thinking strategies and uses those strategies to identify problems. ENTR 350 uses specific design thinking methods to solve problems within existing businesses and organizations.
