Rationale (see instructions):

A. Reduction in the number of required core courses

After a review of the curriculum structure and the undergraduate Management of Aging Services (MAgS) program learning objectives, the core curriculum was changed to better reflect these and the identified core competencies that our students need to develop for current and anticipated future aging services careers.

Also, reducing the number of required core curriculum credits and offering more courses as elective courses would still provide students with core content knowledge in MAgS while also providing them with the opportunity to take elective courses in areas most closely aligned with their MAgS career goals. As careers in aging services are diverse and often cross-disciplinary students would be provided with more choice as to the focus of their program while still gaining the foundational knowledge and experiential learning that would remain within the reduced core curriculum.

AGNG 100 no longer a core course – becomes an elective

Upon review of AGNG 100, it was determined that the material in this course did not include a lot of core required material for the major and could be included as an elective course. AGNG 200 provides core knowledge of the biophysical, psychological, social, and economic aspects of aging which constitutes the foundation of the UG MAgS program. Additionally, AGNG 200 provides a multidimensional and interdisciplinary approach to aging and focuses on the three pillars of the MAgS program: aging, management, and policy.

Also, not including AGNG 100 as a core required course for the MAgS minor would allow students to take more courses in areas of aging services which will most help them to achieve their career goals.

AGNG 351 no longer a core course – becomes an elective

Upon review of AGNG 351, it was determined that the material in this course did not include a lot of core required material for the major and could be included as an elective course. For more in-depth content regarding business decision making in aging services, students could take AGNG 351 as an elective.

AGNG 361 no longer a core course – becomes an elective

Upon review of AGNG 361, it was determined that the material in this course did not include a lot of core required material for the major and could be included as an elective course. For more in-depth content regarding technology in aging services, students could take AGNG 361 as an elective.

AGNG 401 no longer a core course – becomes an elective

Upon review of AGNG 401 it was determined that the most important core material for management of aging services is included in AGNG 310. For more in-depth content regarding aging services management, students could take AGNG 401 as an elective.

B. Elective Courses

Elective Options

In order to ensure that students have the opportunity to take an adequate number of AGNG courses which will enable them to fulfill their career objectives, 12 of their required elective credits will be required to be AGNG courses and they will have the option of taking two aging related courses (6 credits) from outside the program selected from the list of approved elective courses.

Electives listed are those previously offered for either the Management of Aging Studies Major or Minor programs.

SPCH 100 – no longer an approved elective

SPCH 100 has been removed from the list of electives as while it provides useful content for student academic and professional development it does not contain content that specifically relates to aging or aging services.

HAPP 405 becomes an elective.

HAPP 405 has been offered as electives to our MAgS Minors but not as electives for the MAgS Majors. With permission secured (please see Appendix) we propose offering this course as elective options for the students in the MAgS Major as the course content addressing long term care social, economic, and political environments and a focus on management functions within the long term care sector is very relevant to the student of aging services and will provide useful content for our Majors.

Current MAgS Undergraduate BA students will not be impacted by these changes.

Rationale (see instructions):

A. AGNG 415 - change of pre-requisite course from AGNG 200 required to AGNG 200 recommended

While students in the Management of Aging Services Major will have completed AGNG 200 prior to taking this course and it will build upon their course of study, students not enrolled in Management of Aging Services programs could successfully complete this course without these courses. For those purposes and in order to ensure that students from other disciplines who wish to take AGNG 415 as an arts and humanities elective/writing intensive (WI) elective have access to this course, AGNG 200 is recommended rather required. Currently, requiring AGNG 200 as a pre-requisite for AGNG 415 requires students to take a WI course to qualify for AGNG 415 as a WI course.

Current MAgS Undergraduate BA students will not be impacted by this change.

B. AGNG 440 – change of pre-requisite course from AGNG 401 to AGNG 200

After a comprehensive review of the structure of the Management of Aging Services Undergraduate curriculum, carried out during the fall semester of 2019 with the goal of re-structuring the undergraduate curriculum in the undergraduate Management of Aging Studies (MAgS) program, it was determined that AGNG 200 is a more appropriate pre-requisite for AGNG 440 than AGNG 401.

As AGNG 401 and AGNG 440 are not sequential in their course content and curriculum, it was determined that the course content of AGNG 200 provides an enhanced foundation for the upper level AGNG 440. AGNG 200 provides a multidimensional and interdisciplinary approach to aging and focuses on the three pillars of the MAgS program: aging, management, and policy. AGNG 200 will provide the foundational knowledge that learners will build upon in AGNG 440 and will ensure that the learners have the preparation needed to be successful in AGNG 440.

Current MAgS Undergraduate BA students will not be impacted by this change.

**C. AGNG 460 – change in number of required AGNG credits from 15 to a range of 9-15 credits.
Instructor permission added.**

AGNG 460 is part of the internship requirement in the Management of Aging Services major. Students are placed at established agencies that provide services to older adults. Previously 15 AGNG credits were required to ensure that the learners had a good foundational understanding of the theoretical and application of aging to prepare them to either undertake a new project directly related to the management of aging services or participate in an ongoing project designed to improve and/or evaluate services for older adults.

While 15 credits of AGNG courses will still be appropriate for many students in the MAgS undergraduate program, changing the requirement to a range of 9-15 credits will allow for flexibility to account for learners who may have prior experience with the field of aging or relevant experience within their major field of study and may be more prepared as individuals to undertake this internship earlier in their academic program.

Discussions with our MAgS Academic Advisor and AGNG 460 Instructor/Internship Director will determine the appropriate number of credits as a pre-requisite for each individual student to enroll in AGNG 460 within the 9 – 15 credit minimum range. This will allow us to be responsive to the diversity of experience, both academic and in the workplace, of our students and to provide an academic path that is tailored to the individual. By Instructor Permission only is also added to support this process.

Current MAgS Undergraduate BA students will not be impacted by this change.

**D. AGNG 470 – AGNG 460, AGNG 462 and AGNG 463 to become both a pre and co-requisites (previously pre-requisites only).
Instructor permission added.**

While AGNG 460, 462 or 463 (Internship courses) are currently a pre-requisites for AGNG 470 there may be circumstances in which it would be appropriate for students to take an internship class with AGNG 470 (Capstone) within the same semester. While most students do and will continue to take AGNG 460 and AGNG 470 in sequential semesters, allowing 460 or 462 or 463 and 470 to be taken concurrently would allow the MAgS Academic Advisor and/or Internship Director to make individual determinations as to the appropriateness of a student taking these two courses concurrently. By Instructor Permission only is also added to support this process.

Current MAgS Undergraduate BA students will not be impacted by this change.
