## **RATIONALE FOR CHANGE:**

### **Proposal:**

The Department of Music proposes that the number of credits for musical ensembles be reduced from 2 to 1.

### **Why do we propose this change?**

1. To reduce the credit load of our majors, who have some of the highest numbers of required credits in the university. For example, the required music major credits are approximately three times as many as the required psychology major credits.
2. This reduction will give students more flexibility in how they fulfill their University-required Upper Level (UL) credits, allowing for more choice in their degrees.

### **How does this change line up with UMBC's peer institutions?**

UMBC's peer institutions of UMD College Park, Towson University, and UMASS Amherst all offer their ensembles for one credit. In reducing our credits to 1/ensemble, we would be falling in line with the standards set out by these and many other music schools across the country. Offering ensembles for two credits, which we currently do, is higher than most music departments in the country, as confirmed by the National Association of Schools of Music (NASM), our disciplinary accrediting organization.

Our degree credit requirements are currently higher than those at UMD College Park and Towson, in large part due to the discrepancy in ensemble credit. For example, the degree in Music Education requires 101 credits within the major at College Park, 102 at Towson, and 113-115 at UMBC. For a Music Performance major, the number of required credits within the major is 71-84 at UMD College Park, 83-86 at Towson, and 89-92 at UMBC. Reducing the ensemble credit load at UMBC will bring these numbers down to be more comparable to those of our peer institutions. For example, with the proposed change, our Music Education major would be lowered by six credits, and our Music Performance major would be lowered by eight credits.

### **How will this change benefit our majors?**

Giving students room to take more ensembles or electives gives them a sense of ownership over their degrees. At the most recent Provost's Teaching and Learning Symposium, the keynote speaker highlighted the importance of the feeling of ownership in student success. The most recent College Music Association report noted similar findings.

The credit load of our majors is too high to give students any flexibility in their degree programs. Many run into credit overloads when they attempt to take more than the required music classes. This change would give students more choice and allow for greater breadth of experience, which in turn will prepare them better for their careers after graduation.

We also want students to be able to take more ensembles for credit if they choose. Currently, students are frustrated that their credit caps for each semester cannot handle more ensemble experience.

More breadth of performing experience will provide a broader base of experience and will allow our students to be more marketable upon graduation, as well as give them more opportunities for creative cross-pollination of artistic ideas.

Ensembles represent upper level credits, and this change may result in some majors needing to take additional UL credits. These students could choose to fill their UL requirements with additional ensembles or with classes either within the music department or in other departments, again adding more breadth to the major.

### **What would be the impact of this change on our minors?**

The credit load for the music minor is 18-21 depending on the length of the required private lessons in an instrument or voice; with this change, it would be 15-19. The standard for a Minor at UMBC is 18 credits, and we will require at least 18 credits for the Music Minor. Having fewer specified credits would give students more room to explore music electives. A drop in three specified credits could be made up in an additional academic course, more ensembles, or more lessons.

**Implementation**

As we intend to implement this change in Fall 2021, students and department advisors will have one year of advanced notice for planning purposes. Current students will need to make sure they meet their upper level graduation requirements in a timely manner, and departmental advisors will work with these individuals to support their progress to graduation. By giving at least one year of advanced notice, students, in conjunction with our departmental advisors, will be able to plan their final semesters accordingly.
