PROPOSED CATALOG DESCRIPTION (Approximately 75 words in length. Please use full sentences.): (This is identical to the existing GWST 210 description.)

This course introduces students to the field of critical sexuality studies. Using an interdisciplinary approach, the course conducts a critical inquiry into the historical precedents and theoretical frameworks necessary to understand the role of sexuality in shaping personal, social, economic, and political life. The course focuses on patterns of subordination and exclusion based on individuals' sexual practices and identities, explains the origins and persistence of those patterns, and considers ways of challenging them. Throughout the course, special attention will be given to intersections of sexuality with gender, race, ethnicity, religion, class, and disability.

RATIONALE FOR NEW COURSE:

Please explain the following:

a) Why is there a need for this course at this time?

This course is equivalent to the existing GWST 210 course. We are creating this new course as a cross-listing to make it more visible to students in the course catalog and schedule of classes. Students interested in the topic often have trouble finding the course when it is listed at GWST 210. At the same time, we are eliminating the cross-listing with AMST 210 course and the attached email approves the elimination of the AMST cross list and the retirement of the course. Going forward the course would be CSST/GWST 210 and AMST 210 would no longer be listed in the course catalog. As context, please be aware that Carole McCann Professor of GWST created the original course in the late 1990s and GWST has always been the primary department for the course.

b) How often is the course likely to be taught? Every semester

c) How does this course fit into your department's curriculum? This is the required introductory course in the Critical Sexuality Studies Minor (CSST). It also serves as a lower level elective for the Gender and Women's Studies major and minor.

d) What primary student population will the course serve? GWST majors, minors, and CSST minors. As GEP course with an SS/C designation, it also serves first- and second-year students in the completion of their general education requirements.

e) Why is the course offered at the level (ie. 100, 200, 300, or 400 level) chosen? It is offered at the 200 level because it is an introduction to the field of sexuality studies. It assumes no prior knowledge of the field and supports the development of their critical reading and writing skills.

f) Explain the appropriateness of the recommended course preparation(s) and prerequisite(s). As an introductory course no prior preparation is needed.

g) Explain the reasoning behind the P/F or regular grading method. It is offered as regular grading so that students will be able to count it for their degree programs and GEPs.

h) Provide a justification for the repeatability of the course. The course is not repeatable for credit.
